An Act of the Parliament of the Cook Islands to appropriate certain sums of money out of the Cook Islands Government Account to the services of the year ending with the Thirtieth day of June 1993 and to amend the Appropriation Amendment Act 1992

(8 July 1993

MOST GRACIOUS SOVEREIGN, - We, Your Majesty's most dutiful and loyal subjects, the Parliament of the Cook Islands, towards making good the supply which we have cheerfully granted to Your Majesty in this year, have resolved to grant unto Your Majesty the sum hereinafter mentioned and do therefore most humbly beseech Your Majesty that it may be enacted. And be it enacted by the Parliament of the Cook Islands in Session assembled, and by the authority of the same, as follows:

- 1. Short Title and application This Act may be cited as the Appropriation Amendment (No. 2) Act 1992-93, and shall be read together with and deemed part of the Appropriation Act 1992 (hereinafter referred to as "the principal Act").
- 2. Grant and appropriation out of the Cook Islands Government Account Subsection (1) of Section 2 of the principal Act is amended, by deleting the amount of \$68,775,200.00 and substituting the amount of \$67,093,700.00.
- 3. Schedule The principal Act is further amended by deleting the Schedule and substituting the Schedule set out in this Act.
