An Act of the Legislative Assembly of the Cook Islands to appropriate certain sums of money out of the Cook Islands Government Account to the services of the financial year ending with the thirty-first day of March, 1979, and to amend the Appropriation Act 1978 (27 March 1979

MOST GRACIOUS SOVEREIGN, - We Your Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Cock Islands, towards making good the supply which we have cheerfully granted to Your Majesty in this year, have resolved to grant unto Your Majesty the sums hereinafter mentioned and do therefore most humbly beseech Your Majesty that it may be enacted by the Legislative Assembly of the Cock Islands in Session assembled and by the authority of the same, as follows:

1. <u>Short Title</u> - This Act may be cited as the Appropriation Amendment Act 1978-79 and shall be read together with and deemed part of the Appropriation Act 1978 (hereinafter referred to as "the principal Act").

2. Grant and appropriation of \$10,218,300 out of the Cook <u>Islands Government Account</u> - Subsection (1) of section 2 of the principal Act is hereby amended by omitting the amount of \$9,789,400 and substituting the amount of \$10,218,300.

3. <u>Schedule</u> - The principal Act is hereby further emended by omitting the Schedule and substitutin; the following Schedule.
