## 1979-80, No.10

An Act of the Legislative Assembly of the Cook Islands to appropriate certain sums of money out of the Cook Islands Government Account to the services of the financial year ending with the thirty-first day of March, 1980, and to amend the Appropriation Act 1979.

MOST GRACIOUS SOVEREIGN, - We, Your Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Cook Islands, towards making good the supply which we have cheerfully granted to Your Majesty in this year, have resolved to grant unto Your Majesty the sums hereinafter mentioned and do therefore most humbly beseach Your Majesty that it may be enacted: And be it enacted by the Legislative Assembly of the Cook Islands in Session assembled and by the authority of the same, as follows:

- 1. Short Title This Act may be cited as the Appropriation Amendment Act 1979-80 and shall be read together with and deemed part of the Appropriation Act 1979 (hereinafter referred to as "the principal Act").
- 2. Grant and appropriation of \$11,787,700 out of the Cook Islands Government Account Subsection (1) of section 2 of the principal Act is hereby amended by omitting the amount of \$11,551,000 and substituting the amount of \$11,787,700.
- Schedule The principal Act is bereby further amended by omitting the Schedule and substituting the following Schedule.
