An Act to provide that certain enactments of the Parliament of New Zcaland shall extend to the Cook Islands as part of the law of the Cook Islands

(23 December 1969 BE IT ENACTED by the Legislative Assembly of the Cook Islands in

Session assembled, and by the authority of the same, as follows:

1. <u>Short Title</u> - This Act may be cited as the New Zealand Laws Act 1969.

2. <u>New Zealand Acts extended to the Cook Islands</u> - The Acts of the Parliament of New Zealand specified in the First Schedule to this Act are hereby declared to extend to the Cook Islands as part of the law of the Cook Islands.

3. <u>New Zealand regulations and orders extended to the</u> <u>Cook Islands</u> - The regulations and orders specified in the Second Schedule of this Act are hereby declared to extend to the Cook Islands as part of the law of the Cook Islands.

4. <u>Telephone Regulations 1968 extended to Cook Islands</u> with <u>amendments</u> - The New Zealand Telephone Regulations 1968 (Stututory Regulations Serial No.1968/234) are hereby declared to extend to the Cook Islands as part of the law of the Cook Islands with the following amendments -
