HIS EXCELLENCY THE QUEEN'S REPRESENTATIVE IN EXECUTIVE COUNCIL

PURSUANT to Section 29 of the General Licensing Authority Act 1989, the Queen's Representative, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations:

REGULATIONS

- 1. <u>Title</u> (1) These regulations shall be cited as the Restaurant Licensing Fee Regulations 1991.
- 2. <u>Interpretation</u> In these regulations, unless the context otherwise requires -
 - "Act" means the General Licensing Authority Act 1989.
 - "Authority" means the General Licensing Authority established by the General Licensing Authority Act 1989.
- 3. <u>Application of regulations</u> Application and Annual licence fees are payable in respect of the Act for licences of restaurants issued under Part III of the Act as set out in these regulations.

- 4. <u>Application fees</u> A fee of \$20.00 is payable upon application being made for a restaurant, cafe, cafeteria, mobile food outlets and takeaways licence.
- 5. Amount of licence fees Fees for the rates set out in the Schedule to these regulations are payable for restaurant, cafe, cafeteria, mobile food outlets and takeaways, and special licences.
- 6. <u>Annual licence fees</u> Fees under Regulation 5 are payable annually.
- 7. <u>Payment of Fees</u> Fees payable annually for licences for restaurants under the Act are payable:
 - (a) where the licence is issued or renewed for a period of 12 months commencing on 1 July in any year on or before that 1 July; and
 - (b) in any other case on or before the issue of the licence.
- 8. Fees payable to Authority Fees payable under these regulations are payable to the Authority.
