# **Companies (Amendment) Regulations 2021**

IN exercise of the powers conferred on me by section 713 of the Companies Act 2015, I hereby make these Regulations—

#### Short title and commencement

- 1.-(1) These Regulations may be cited as the Companies (Amendment) Regulations 2021.
  - (2) These Regulations come into force on 1 January 2022.
- (3) In these Regulations, the Companies Regulations 2015 is referred to as the "Principal Regulations".
