COUNTER-INFLATION ACT (Cap. 73)

Counter-Inflation (Price Control) (Wheat Products Ex-factory) (No. 9) Order 2009

In exercise of the powers conferred upon it by section 9 of the Counter-Inflation Act, the Prices and Incomes Board, with the approval of the Prime Minister &Acting Minister for Finance and National Planning makes the following Order—

Citation and Commencement

1. This Order may be cited as the Counter-Inflation (Price Control) (Wheat Products-Ex-Factory) (No. 9) Order 2009 and comes into force on 19th June 2009.

Maximum prices schedule

- 2.—(1) Subject to sub paragraph (2) below the prices set out in Part 1 of the Schedule are the maximum prices at which the goods mentioned in that Part may be sold and delivered ex-factory.
- (2) Where the maximum price of an item listed in Part 1 of the schedules is required to be rounded up to the nearest whole number by reason of the cessation of the 1 cent and 2 cents denominations, the consequential increase in the price of that does not constitute a contravention of this Order.
- (3) Ex-factory delivered prices apply from the factory to the areas designated in Part 2 of the Schedule.
 - (4) Part 3 of the Schedule applies in respect of areas not designated in Part 2.

Value Added Tax (VAT)

3. Manufacturers must state Value Added Tax (VAT) separately in the invoice provided at the time of sale.

Revocation

4. The Counter-Inflation (Price Control) (Wheat Products-Ex-Factory) (No. 2) Order 2009 is revoked.

PART 2

Ex-factory delivered price shall apply to the following areas—

- (a) the cities of Suva and Lautoka;
- (b) the towns of Ba, Lami, Nadi, Sigatoka, Tavua, Nausori and Nasinu; and an area from the prescribed boundary of the city of Suva at Nabua on the King's Road to the prescribed boundary of the town of Nausori at Davuilevu on the King's Road to a width of 3 kilometers on either side from the center point of that road; and
- (c) the areas on the island of Viti Levu within a radius of 5 kilometers from any of the post offices situated at Korovou, Navua or Rakiraki.

PART 3

- (a) A reasonable delivery cost may be charged to any area on the island of Viti Levu not designated in Part 2.
- (b) A delivery cost must relate only to the cost of delivery beyond the areas designated in Part 2
- (c) A freight subsidy of \$20 per tonne for any place outside Viti Levu shall be paid by the Manufacturer of goods specified in Part 1.

COUNTER-INFLATION ACT (CAP. 73)

Counter-Inflation (Price Control) (NAVUA'S FIRST STOP SUPERMARKET LIMITED) (Exemption) Order 2009

In exercise of the powers conferred upon it by section 20 of the Counter-Inflation Act, and all other powers enabling it in that behalf, the Prices and Incomes Board, with the approval of the Prime Minister and Acting Minister for Finance and National Planning, makes the following order—

Citation and commencement

1. This Order may be cited as the Counter-Inflation (Price Control) (NAVUA'S FIRST STOP SUPERMARKET LTD) (Exemption) Order 2009 and comes into force on 19th June 2009.

Exemption from individual price marking of price controlled products.

- 2.—(1) Subjected to sub-clause (2) of this clause, the provisions of the orders made prior to this order, and subsequent thereto, under section 9 and 23 (a) of the Counter-Inflation Act, requiring any person having price controlled products for sale be retail to have the product individually marked with the maximum price for information of the public shall not apply to NAVUA'S FIRST STOP SUPERMARKET LIMITED, NAVUA.
- (2) For the purpose of the exemption granted by this Order, NAVUA'S FIRST STOP SUPERMARKET LIMITED shall—
 - (a) Install and use in its retail outlet, in place of Electronic Cash Registers, a Point Of Sale (otherwise known as POS) Terminal System with Bar Code Scanner;
 - (b) Shelf -price retail products subject to price control by displaying in a prominent position, either on the shelf or the place or such other vicinity, where the products are exhibited, a legible and conspicuous notice indicating—
 - (i) the product to which the notice relates;
 - (ii) product names;
 - (iii) product size (if applicable); and
 - (iv) the maximum price per product.
 - (c) Issue to the purchaser a receipt fully indicating—
 - (i) the retailer's name;
 - (ii) product name;
 - (iii) product size (if applicable);
 - (iv) unit price and quantity price where more than one of a particular product is purchased;
 - (v) total cost of the product purchased;
 - (vi) amount tendered for purchases by customer;
 - (vii) the change due to the customer, and

Comply with any other condition as the Prices and Incomes Board may from (d) time to time deem necessary to impose.

Form of Receipt

3. The receipt issued to the purchaser under clause 2 (2) (c) of this Order shall be in the form of samples shown in the Schedule to this Order, subject to amendment as the Prices and Incomes Board may at any deem necessary to direct.

Scope of exemption

4. The Exemption granted by this Order applies only to the requirement under the Order mentioned in sub-clause (1) of clause 2 for individual price marking of price controlled products sold by retail and in no way affects any other provision of such Orders.
