CONSTITUTION OF THE REPUBLIC OF FIJI  
(Section 92(3))

**Ministerial Assignment**

To: Mr Viliame Rogoibulu Gavoka  
Deputy Prime Minister and Minister for Education, Tourism and Civil Aviation

WHEREAS, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I assigned to you in your capacity as the Deputy Prime Minister and Minister for Tourism and Civil Aviation with effect from 24 December 2022, the responsibility for the conduct of Government businesses, divisions and written laws specified in Legal Notice No. 4 of 2023;

WHEREAS, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I assigned to you in your capacity as the Deputy Prime Minister and Minister for Tourism and Civil Aviation with effect from 1 August 2023, the responsibility for the conduct of Government businesses, divisions and written laws specified in Legal Notice No. 69 of 2023;

NOW THEREFORE, in exercise of the powers vested in me as the Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I hereby revoke with effect from 22 January 2024, all assignments and responsibilities under Legal Notice No. 69 of 2023, and with effect from the same day assign to you in your capacity as the Deputy Prime Minister and Minister for Education, Tourism and Civil Aviation the responsibility for the conduct of the following Government businesses, divisions and written laws (subject to the provisions of any other written law)—
