PUBLIC HOSPITALS AND DISPENSARIES ACT (CAP. 110)

Public Hospitals and Dispensaries (Amendment) Regulations 2013

IN exercise of the powers conferred upon me by section 6 of the Public Hospitals and Dispensaries Act (Cap. 110), I hereby make these Regulations—

Short title and commencement

1.-(1) These Regulations may be cited as the Public Hospitals and Dispensaries (Amendment) Regulations 2013, and shall be deemed to have come into force on 17th September, 2012.

(2) The Public Hospitals and Dispensaries Regulations shall be referred to as the "Principal Regulations".

Regulation 2 amended

2. Regulation 2 of the Principal Regulations is amended by inserting the following new definition after the definition of "medical practitioner"—

"Sahyadri Speciality Pacific Hospital Limited" means a company incorporated under the Companies Act (Cap. 247) and having its registered address at 43 Gordon Street, Suva, Fiji;"

New regulation inserted

3. The Principal Regulations are amended by inserting the following new regulation after regulation 20-

"Charges of Sahyadri Speciality Pacific Hospital Limited

20A. The charges set out in the Third Schedule shall apply to every patient treated by the Sahyadri Speciality Pacific Hospital Limited in Fiji."

Third Schedule inserted

4. The Principal Regulations are amended by inserting the following new schedule after the Second Schedule---
