## REGISTRATION OF SKILLED PROFESSIONALS ACT 2016 (ACT No. 8 of 2016)

## **Registration of Skilled Professionals Regulations 2016**

IN exercise of the powers conferred upon me by section 17 of the Registration of Skilled Professionals Act 2016, I hereby make these Regulations—

#### Short title and commencement

- 1.—(1) These Regulations may be cited as the Registration of Skilled Professionals Regulations 2016.
  - (2) These Regulations come into force on the date the Act comes into force.

#### Interpretation

- 2.—(1) In these Regulations, unless the context otherwise requires—
  - "Act" means the Registration of Skilled Professionals Act 2016; and
  - "special registration" means the registration of a skilled professional by the Committee.
- (2) In these Regulations, words and phrases have the same meaning as under the Act unless the context otherwise requires.

#### Professions

3. For the purpose of the definition of "skilled professional" in section 2 of the Act, a "profession" means a paid occupation that requires a formal qualification or specialised areas of training.

#### Application for special registration

- 4.—(1) For the purpose of section 9 of the Act and notwithstanding any other written law, any individual may make an application to the Committee for special registration as a skilled professional.
  - (2) An application under subregulation (1) must be—
    - (a) made in the form in the Schedule; and
    - (b) accompanied by a prescribed fee equivalent to zero dollars.
- (3) The Committee must immediately disregard any application that does not comply with subregulation (2).
- (4) When considering an application for special registration, including any supporting documentation, the Committee may have regard to the following—
  - (a) the profession within which the applicant is qualified or has expertise in;
  - (b) the qualification or training of the applicant;
  - (c) the country where the applicant obtained his or her qualification or training;

- (d) the relevant professional experience of the applicant;
- (e) the country or countries where the applicant has worked in the profession;
- (f) the standards of any relevant professional body in Fiji;
- (g) whether the applicant has any pending criminal charges or is a party to any current civil proceedings in any country; and
- (h) whether the applicant has any previous criminal conviction or has been subjected to any order made against him or her in any civil proceedings in any country.
- (5) The Committee may invite any person or organisation to provide advice or information on an application for special registration or any other matter.
- (6) The Committee may, at any time, make necessary amendments to the form in the Schedule.
