AN ACT

To further amend Public Law No. 6-49, as amended, by further amending section 1, as amended by Public Laws Nos. 6-55 and 6-96, to modify the use of funds appropriated therein for Chuuk State public projects, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Section 1 of Public Law No. 6-49, as amended by 2 Public Laws Nos. 6-55 and 6-96, is hereby further amended to read as 3 follows: "Section 1. Statewide public projects. The sum of 4 \$200,000, or so much thereof as may be necessary, is hereby 5 appropriated from the General Fund of the Federated States 6 7 of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding certain statewide public projects 8 in Chuuk State.
