## AN ACT

To further amend Public Law No. 6-72, as amended by Public Laws Nos. 6-94, 6-100, and 6-110, by further amending section 2, as amended by Public Law No. 6-94, to modify the use of funds previously appropriated for elementary and secondary education related projects and programs in Chuuk State, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Section 2 of Public Law No. 6-72, as amended by
2	Public Law No. 6-94, is hereby further amended to read as follows:
3	"Section 2. Elementary and secondary education related
4	projects and programs in Chuuk. The sum of \$525,000,
5	or so much thereof as may be necessary, is hereby
6	appropriated from the General Fund of the Federated States
