## AN ACT

To appropriate the sum of \$1,300,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, for the purpose of funding construction or renovation of Centers for Continuing Education in each of the States and for funding the purchase of furnishings, equipment or supplies for the CE Centers, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

 Section 1. The sum of \$1,300,000, or so much thereof as may be
 necessary, is hereby appropriated from the General Fund of the
 Federated States of Micronesia for the fiscal year ending September
 30, 1993, for the purpose of funding construction or renovation of
 Centers for Continuing Education in each of the States and for
 funding the purchase of furnishings, equipment or supplies for the CE
 Centers.

8 Section 2. The sum appropriated under section 1 of this act 9 shall be apportioned as follows:

(1) Chuuk Center for Continuing Education....\$500,000 10 (2) Yap Center for Continuing Education..... 250,000 11 12 (3) Kosrae Center for Continuing Education.... 250,000 (4) Pohnpei Center for Continuing Education... 300,000 13 14 Section 3. All funds appropriated by this act shall be 15 allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial 16 Management Act of 1979. The President or the President's designee 17 18 shall be the allottee, who shall be responsible for ensuring 19 that these funds, or so much thereof as may be necessary, are used 20 solely for the purpose specified in this act, and that no obligations 21 are incurred in excess of the sum appropriated. The authority of the 22 allottee to obligate funds appropriated by this act shall lapse
