Public Law No. 7 - 110

AN ACT

To appropriate the sum of \$20,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, for the purpose of providing supplemental funding to the Department of Transportation and Communication so marine technicians can evaluate potential replacements for the MS Caroline Islands and the field trip ships, and for the purpose of providing supplemental funding to the Congress of the Federated States of Micronesia for fuel for government vessels and for fuel for automobiles so members can conduct public hearings on the outer islands or in their respective election districts, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. The sum of \$10,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the 2 3 Federated States of Micronesia for the fiscal year ending September 30, 1993, for the purpose of providing supplemental funding to the 4 Department of Transportation and Communication so marine technicians 5 can evaluate potential replacements for the MS Caroline Islands and 6 7 the field trip ships.

8 Section 2. The sum of \$10,000, or so much thereof as may be 9 necessary, is hereby appropriated from the General Fund of the 10 Federated States of Micronesia for the fiscal year ending September 30, 1993, for the purpose of providing supplemental funding to the 11 12 Congress of the Federated States of Micronesia for fuel for government 13 vessels and for fuel for automobiles so members can conduct public 14 hearings on the outer islands or in their respective election 15 districts.

Section 3. All funds appropriated by this act shall be 16 17 allotted, managed, administered, and accounted for in accordance with 18 applicable law, including, but not limited to, the Financial Management Act of 1979. The allottees shall be responsible for 19 20 ensuring that these funds, or so much thereof as may be necessary, 21 are used solely for the purposes specified in this act, and that no 22 obligations are incurred in excess of the sum appropriated.
