

**PRESIDENTIAL COMM. NO. 7-394**  
**FSM CONGRESS**

**Public Law No. 7 - 115**

AN ACT

To further amend Public Law No. 6-74, Pohnpei State public projects, as amended by Public Laws Nos. 6-101, 7-71 and 7-72, by further amending section 4, as amended by Public Law No. 6-101, to modify the use of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 6-74, as amended by  
2 Public Law No. 6-101, is hereby further amended to read as follows:

3 "Section 4. Statewide public projects. The sum of  
4 \$525,000, or so much thereof as may be necessary, is hereby  
5 appropriated from the General Fund of the Federated States  
6 of Micronesia for the fiscal year ending September 30,  
7 1990, for the purpose of funding certain statewide public  
8 projects in Pohnpei State. The sum appropriated by this  
9 section shall be apportioned as follows:

- 10 (1) Pohnpei medical services..... \$ 75,000
- 11 (2) Dental services..... 25,000
- 12 (3) Pohnpei Farmers' Home Administration.. 27,000
- 13 (4) PICS High School..... 35,000
- 14 (5) M/S Micro Glory..... 35,000
- 15 (6) Pohnpei Sports Council: Rahn en  
16 Mweimwau..... 16,000
- 17 (7) Reimbursement to House of Travel for  
18 travel costs of Pohnpei State representatives  
19 in sports competition in Guam and Saipan..... 17,000
- 20 (8) Pohnpei Community Action Agency  
21 projects, programs and administration..... 70,000
- 22 (9) Ohwa Christian High School
