## AN ACT

To appropriate the sum of \$1,080,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of assisting State-administered public health programs throughout the Federated States of Micronesia, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. The sum of \$500,000, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the Federated
3	States of Micronesia for the fiscal year ending September 30, 1995, to
4	assist State-administered public health programs in the State of Chuuk. The
5	funds appropriated by this section shall be apportioned as follows:

7	(a) Munien dispensary\$ 20,000
8	(b) Neirenom (Neppi) dispensary 15,000
9	(c) Wonei (Saputiw) 20,000
10	(d) Manaio dispensary 10,000

14	purpose of financing the construction of two super dispensaries in the State
15	of Pohnpei. The sum of \$180,000 is further apportioned as follows:
16	(1) Sokehs Municipality\$ 100,000

18	Section 4. The sum of \$200,000, or so much thereof as may be
19	necessary, is hereby appropriated from the General Fund of the Federated
20	States of Micronesia for the fiscal year ending September 30, 1995, to
21	assist State-administered public health programs in the State of Yap. The
22	funds appropriated by this section shall be apportioned as follows:

11	allottee of the funds appropriated by subsections (1) and (6) of	section 1
12	of this act shall be the Chuuk State Director of Health Services	. The
13	allottee of the funds appropriated by subsection (2) of section	1 of this
14	act shall be the Southern Namoneas Development Authority. The al	lottee of
15	funds appropriated by subsections $(3)$ , $(4)$ and $(5)$ of section 1	of this act
16	shall be the Secretary of the Department of Health Services of t	he Federated
17	States of Micronesia or his designee. The allottee of the funds	appropriated
18	by section 2 of this act shall be the Governor of Kosrae or his	designee.
19	All other funds appropriated by this act shall be the President	of the
20	Federated States of Micronesia or the President's designee. The	allottees
21	shall be responsible for ensuring that these funds, or so much t	hereof as
22	may be necessary, are used solely for the purpose specified in t	his act, and
23	that no obligations are incurred in excess of the sum appropriat	ed. The
24	authority of the allottees to obligate funds appropriated by thi	s act shall
25	lapse as of September 30, 1997.
