AN ACT

To amend Public Law No. 8-100, by amending section 6 for the purpose of changing the allottee of certain funds appropriated under section 4 of Public Law No. 8-100, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 8-100 is hereby amended to

"Section 6. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under subsections (1), (3), (5), (6), (7), (8), and (9) of section 1 of this act shall be the Secretary of Education. The allottee of the funds appropriated under subsection (2) of section 1 of this act shall be the Lower Mortlocks Development Authority. The allottee of the funds appropriated under subsection (4) of section 1 of this act shall be the Southern Namoneas Development Authority. The allottee of the funds appropriated under section 2 of this act shall be the Governor of the State of Kosrae. The allottee of the funds appropriated under subsections (1), (3), and (4) of section 4 of this act shall be the Governor of the State of Yap. The allottee of the funds appropriated under subsection (2) of section 4 of this act shall be the President of the College of Micronesia - FSM. The allottee of all other funds appropriated by this act shall be the President of the Federated States of Micronesia or the President's designee.

Public Law No. 8 - 12 2

AN ACT

To appropriate the sum of \$182,711 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of funding out-of-pocket housing expenses for National Government employees and overtime accrued by the National Police and the Division of Immigration at the end of the fiscal year 1994, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
