AN ACT

To appropriate the sum of \$550,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of funding programs in the State of Chuuk and the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$350,000, or so much thereof as may be	
2	necessary, is hereby appropriated from the General Fund of the Federated State	es
3	of Micronesia for the fiscal year ending September 30, 1995, for the purpose of	f
4	funding fisheries programs in the State of Chuuk. The funds appropriated by the	is
5	act shall be apportioned as follows:

15	this act shall be apportioned as follows:

18	Section 3. All funds appropriated by this act shall be allotted, managed,	
19	administered, and accounted for in accordance with applicable law, including, be	ut
20	not limited to, the Financial Management Act of 1979. The allottee of the funds	•
21	appropriated under subsection (1) of section 1 of this act shall be the Office of	f
22	Planning and Statistics of the National Government; the allottee of the

1	funds appropriated under subsection (2) of section 1 of this act shall be the
2	Northern Namoneas Development Authority; the allottee of the funds
3	appropriated under subsection (3) of section 1 of this act shall be the Southern
4	Namoneas Development Authority; the allottee of the funds appropriated under
5	subsection (4) of section 1 of this act shall be the Mortlocks Development
6	Authority; and the allottee of the funds appropriated under subsection (5) of
7	section 1 of this act shall be the Pattiw Development Authority. The allottee of
8	the funds appropriated under section 2 of this act shall be the Governor of the
9	State of Pohnpei. The allottees shall be responsible for ensuring that these funds,
10	or so much thereof as may be necessary, are used solely for the purpose
11	specified in this act, and that no obligations are incurred in excess of the sum
12	appropriated. The authority of the allottees to obligate funds appropriated by
13	this act shall not lapse.
14	Section 4. This act shall become law upon approval by the President of the
15	Federated States of Micronesia or upon its becoming law without such approval.
