Public Law No. 8-148

AN ACT

To further amend Public Law No. 7-24, as amended, Pohnpei State public projects, by further amending section 5, as amended by Public Laws Nos. 7-63, 7-74, 7-84, 7-105, 8-40, and 8-119, for the purpose of changing the allottee of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

	DETT ENACTED BY THE GONALISOS OF THE FEDERAL BOTALES OF WHO HONESIA.
1	Section 1. Section 5 of the Public Law No. 7-24, as amended by
2	Public Laws Nos. 7-63, 7-74, 7-84, 7-105, 8-40 and 8-119, is hereby
3	further amended to read as follows:
4	"Section 5. All funds appropriated by this act shall be
5	allotted, managed, administered, and accounted for in
6	accordance with applicable law, including, but not limited to,
7	the Financial Management Act of 1979. The allottee of the
8	funds appropriated under subsections (6), (7), (8), (9),
9	(10), (11), (12), (13), (14), (15), (16) and (19) of
0	section 1 of this act and all subsections except subsection
1	(10) and (11) of section 3 of this act shall be the President
2	of the Federated States of Micronesia or his designee. The
3	allottee of the funds appropriated under subsection (1) of
4	section 2 of this act shall be the Meninkederlapalap of the
5	Municipality of Madolenihmw. The allottee of the funds
6	appropriated under subsection (2) of section 2 of this act
7	shall be the Luhkenmoanlap of the Municipality of Kitti. The
8	allottees of the funds appropriated under section 2 of
9	this act shall submit detailed funds status and project status
20	reports to the Congress of the Federated States of
21	Micronesia at the beginning of each quarter of each fiscal

year until the funds appropriated thereunder are fully



1	expended. The allottee of the funds appropriated under
2	section 4 of this act shall be the Governor of Pohnpei State.
3	The allottee of the funds appropriated under subsection (1)
4	of section 1 of this act and subsection (10) of section 3 of
5	this act shall be the Pohnpei State PTA. The allottee of the
6	funds appropriated under subsection (2) of section 1 of this
7	act shall be the Mayor of Kolonia Town. The allottee of the
8	funds appropriated under subsections (3), (4), (17) and
9	(18) of section 1 of this act shall be the Chief Magistrate of
10	Sokehs Municipality. The allottee of the funds appropriated
11	under subsection (5) of section 1 of this act shall be the
12	Luhkenkolwof of Sapwuahfik Municipality. The allottee of the
13	funds appropriated under subsection (11) of section 3 of
14	this act shall be the Farmers Home Administration. The
15	allottees shall be responsible for ensuring that these funds,
16	or so much thereof as may be necessary, are used solely for
17	the purposes specified in this act, and that no obligations are
18	incurred in excess of the sum appropriated. The authority o
19	the allottee of the funds appropriated under subsection (15)
20	of section 1 of this act to obligate funds shall lapse
21	as of September 30, 1994. The authority of all other
22	allottees to obligate funds appropriated by this act shall not
23	lapse."
