FIRST CONGRESS OF THE FEDERATED STATES OF MICRONESIA PUBLIC LAW NO. 1-9 FIRST REGULAR SESSION, 1979 CONGRESSIONAL BILL NO. 1-25, C. D. 1

AN ACT

To appropriate the sum of \$97,600 from the General Fund of the Congress of the Federated States of Micronesia for the purpose of defraying contingent and incidental expenses of the President and Vice President of the Federated States of Micronesia for Fiscal Year 1979, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$97,600, or so much thereof as may be necessary,
2	is hereby appropriated from the General Fund of the Congress of the
3	Federated States of Micronesia for the purpose of defraying the contingent
4	and incidental expenses of the President and Vice President of the
5	Federated States of Micronesia for the period commencing May 15, 1979 and
6	ending on September 30, 1979. The sum appropriated by this act shall be
7	apportioned as follows:
8	(1) Travel and per diem
9	(2) Materials and supplies
10	(3) Equipment
11	(4) Furniture
12	Section 2. The sum appropriated by Section 1 shall be allotted by
13	the Director of the Bureau of Finance, Department of Administrative
14	Services of the Trust Territory of the Pacific Islands, to the Director
15	of the Department of Finance, or to the Budget Officer of the Federated
16	States of Micronesia, or in their absence, to an official designated by
17	the President of the Federated States of Micronesia. The said allottee
18	shall be legally responsible to the President for ensuring that these funds
19	are used only for the purposes specified in Section 1, and that no
20	obligations are incurred in excess of the sum appropriated. Any sum
21	remaining unobligated or unexpended as of September 30, 1979, shall
22	revert to the General Fund of the Congress of the Federated States of

1 Micronesia.

2 Section 3. The allottee specified in Section 2 shall, by not later than October 15, 1979, submit a detailed report to the President of the 3 4 Federated States of Micronesia and the Speaker of the Congress of the 5 Federated States of Micronesia, which report shall provide for full accounting by object class of the obligations incurred against the funds 6 appropriated by this act. The allottee may, if authorized to do so by the 7 8 President or Vice President, reallot the funds appropriated by Section 1; PROVIDED, HOWEVER, that no reallotment may exceed fifteen per cent of any 9 line item nor may any funds be reallotted for the purpose of hiring 10 unbudgeted personnel. 11

Section 4. Upon approval by the President of the Federated States 12 of Micronesia, or upon its becoming law without such approval, this act 13 shall take effect retroactively to May 15, 1979. 14
