

AN ACT

To appropriate the sum of \$643,000 from the General Fund of the Congress of the Federated States of Micronesia for the Annual Budget of the government of the Federated States of Micronesia for fiscal year 1980, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$643,000, or so much thereof as may be  
2 necessary, is hereby appropriated from the General Fund of the Congress  
3 of the Federated States of Micronesia for the Annual Budget of the  
4 government of the Federated States of Micronesia for fiscal year 1980.

5 The sum appropriated by this act shall be apportioned as follows:

- 6 (1) Office of the President and Vice President . . . \$ 84,000
- 7 (2) Executive Branch Operations . . . . . 150,000
- 8 (3) Micronesian/Washington Office . . . . . 89,000
- 9 (4) Department of Finance, Revenue Division . . . . . 133,000
- 10 (5) Micronesian Maritime Authority . . . . . 127,000
- 11 (6) Joint Delegation of the Federated States of  
12 Micronesia to the U.N. Law of the Sea Conference . . . . . 32,000
- 13 (7) Vocational Agricultural Programs pursuant to  
14 Public Law Nos. 3C-52 and 5-83 . . . . . 20,000
- 15 (8) FSM Contribution to the South Pacific  
16 Commission . . . . . 3,000
- 17 (9) FSM Contribution to the East West Center,  
18 University of Hawaii . . . . . 5,000

19 Section 2. The sum appropriated by Section 1 shall be allotted by  
20 the Director of the Bureau of Finance, Department of Administrative  
21 Services of the government of the Trust Territory of the Pacific Islands  
22 to the President of the Federated States of Micronesia, or his designee.

1 The allottee shall be legally responsible to the Congress of the  
2 Federated States of Micronesia for ensuring that these funds are used  
3 only for the purposes specified in Section 1, and that no obligations are  
4 incurred in excess of the sum appropriated. Any sum remaining unobligated  
5 as of September 30, 1980 shall revert to the General Fund of the Congress  
6 of the Federated States of Micronesia.

7 Section 3. The President shall, by not later than May 1, 1980, submit  
8 a detailed report to the Congress of the Federated States of Micronesia,  
9 which report shall provide for full accounting by line item and by object  
10 class of the obligations as of March 31, 1980 incurred against the funds  
11 appropriated by this act and present his Annual Budget request for fiscal  
12 year 1981. The President may reallocate up to ten percent of any line item  
13 apportioned by Section 1.

14 Section 4. This act shall take effect upon approval by the President  
15 of the Federated States of Micronesia, or upon its becoming law without  
16 such approval.
