

AN ACT

To apportion the sum of \$266,000 made available for the Fiscal Year 1980 operations and contingent expenses of the Revenue Division; to authorize the appropriation of \$133,000 from the General Fund of the Congress of the Federated States of Micronesia as the Congress' contribution to one-half of the operating and contingent expenses of the Revenue Division; to assess against the states and to authorize withholding therefrom the total sum of \$133,000 as the states' contribution to one-half of the operating and contingent expenses of the Revenue Division, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The total sum of \$266,000 shall be made available for the  
2 purpose of defraying the operating and contingent expenses of the Revenue  
3 Division for Fiscal Year 1980, and shall be apportioned in the following  
4 manner:

- 5 (1) Staff salaries and personnel benefits . . . . . \$136,400
- 6 (2) Contractual services . . . . . 29,900
- 7 (3) Travel . . . . . 20,100
- 8 (4) Other support costs . . . . . 29,600

9 Section 2. The sum of \$133,000, or so much thereof as may be  
10 necessary, is hereby authorized to be appropriated from the General Fund  
11 of the Congress of the Federated States of Micronesia as the Congress'  
12 contribution to one-half of the operating and contingent expenses of the  
13 Revenue Division for Fiscal Year 1980.

14 Section 3. The states of the Federated States of Micronesia are  
15 hereby assessed, and the Revenue Division is authorized to withhold there-  
16 from the total sum of \$133,000 as the states' contribution to one-half of  
17 the operating and contingent expenses of the Revenue Division for Fiscal  
18 Year 1980. Each state shall be so assessed in accordance with the follow-  
19 ing schedule:

- 20 (1) Yap . . . . . \$26,000

1           (4) Kosrae . . . . . \$ 7,000

2 The sums withheld pursuant to authority vested by this Section shall be  
3 used solely for the purpose of defraying the operating and contingent  
4 expenses of the Revenue Division for Fiscal Year 1980 in accordance with  
5 the schedule set forth in Section 1 of this act.

6           Section 4. The Chief of the Revenue Division shall be personally and  
7 legally responsible to the Congress of the Federated States of Micronesia  
8 for ensuring that no obligations are incurred in excess of the sums made  
9 available by this act. Any part of the sum made available by this act  
10 not obligated as of September 30, 1980 shall revert one-half to the  
11 General Fund of the Congress of the Federated States of Micronesia and  
12 one-half to the treasuries of the states, with each state receiving a  
13 percentage corresponding to the percentage of its contribution to the  
14 states' share of the cost of collecting taxes.

15           Section 5. The Chief of the Revenue Division shall submit a detailed  
16 report to the Budget Officer of the Congress of the Federated States of  
17 Micronesia before July 14, 1980 which shall:

18           (1) provide for the full accounting by object class of the  
19 obligations incurred against the sum made available by this act, including  
20 justification for any significant deviations from line items, and indicate  
21 the status of these funds as of June 30, 1980;

22           (2) indicate the planned use, during the final quarter of the  
23 Congressional Fiscal Year, of funds not obligated as of June 30, 1980; and

24           (3) present the fiscal support requirements of the activity  
25 for Congressional Fiscal Year 1981.

1 Section 6. This act shall take effect upon approval by the President  
2 of the Federated States of Micronesia, or upon its becoming law without  
3 such approval.
