

AN ACT

To appropriate the sum of \$3,500,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2010, for the purpose of funding Economic and Social Projects and Programs in the States of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$3,500,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2010, for the purpose of funding Economic and Social
5 Projects and Programs in the States of Yap, Kosrae, Pohnpei and
6 Chuuk. The funds appropriated under this section shall be
7 apportioned as follows:

21 Section 2. Allotment and management of funds and lapse date.

22 All funds appropriated by this act shall be allotted, managed,
23 administered and accounted for in accordance with applicable
24 laws, including, but not limited to, the Financial Management Act
25 of 1979. The allottee shall be responsible for ensuring that

1 these funds, or so much thereof as may be necessary, are used
2 solely for the purpose specified in this act, and that no
3 obligations are incurred in excess of the sum appropriated. The
4 allottee of the funds appropriated under section 1 of this act
5 shall be the President of the Federated States of Micronesia or
6 his designee; PROVIDED THAT the allottee of funds appropriated
7 under sections 1(4)(a), (d) and (e) of this act shall be the
8 Chuuk Commission on Improvement Project (CSCIP). The allottee of
9 funds appropriated under section 1(1) of this act shall be the
10 Governor of the State of Yap. The allottee of funds appropriated
11 under section 1(3)(c)(ii)(iv) and (vi) shall be the Madolenihmw
12 Menin Keder Lapalap (Mayor of Madolenihmw). The authority of the
13 allottee to obligate funds appropriated by this act shall not
14 lapse.
