CONGRESSIONAL BILL NO. 2-282

AN ACT

To amend title 30 of the Code of the Federated States of Micronesia by adding a new section 114 to provide for the establishment of the Federated States of Micronesia Revolving Economic Development Loan Fund and authorizing appropriations therefor, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. A new section 114 is hereby added to title 30 of the
 Code of the Federated States of Micronesia to read as follows:

 "Section 114. Federated States of Micronesia Revolving
 Economic Development Loan Fund.
 - (1) There is hereby established the Federated States of Micronesia Revolving Economic Development Loan Fund (hereinafter the 'fund') separate from the General Fund and other funds.
 - (2) The purpose of the fund is to establish an ongoing revolving fund to provide long-term low interest economic development loans to qualified citizens of the Federated States of Micronesia.
 - (3) Unless otherwise required by law, all past and future appropriations to the Bank for economic development loans to citizens of the Federated States of Micronesia shall be deposited into the fund. All repayments of principal and interest for loans made from the fund shall be deposited back into the fund for the purpose stated in subsection 2 of this section. Further, all repayments of principal and interest for loans made pursuant to Public Law No. 2-11 shall be deposited into the fund. Any unexpended money in the fund shall not revert to the

1	General Fund or lapse at the end of the fiscal year.
2	(4) The fund and loans from the fund shall be
3	administered, managed, and accounted for in accordance
4	with the provisions of this chapter, other applicable
5	law, and policies and procedures established by the
6	Board of Directors of the Bank.
7	(5) The President of the Bank shall prepare and
8	submit to the Congress of the Federated States of
9	Micronesia and the President of the Federated States of
10	Micronesia annually, within 90 days after the close of
11	its fiscal year, a report on the status of the fund to
12	include:
13	(a) The total amount of money currently in
14	the fund;
15	(b) The total amount of outstanding current
16	loans;
17	(c) The total amount of repayments collected
18	in the prior fiscal year;
19	(d) The total amount of payments in default
20	in the prior fiscal year;
21	(e) The number of loans made during the prior
22	fiscal year; and
23	(f) Such other information as may be required
24	by the Congress or the President.
25	(6) Appropriations from the General Fund of the

1	Federated States of Micronesia are hereby authorized for
2	the purpose stated in subsection (2) of this section."
3	Section 2. Sections 114, 115, 116, 117, 118, and 119 of title
4	30 of the Code of the Federated States of Micronesia are hereby
5	renumbered to be sections 115, 116, 117, 118, 119, and 120, respective
6	Section 3. This act shall become law upon approval by the Preside
7	of the Federated States of Micronesia or upon its becoming law without
8	such approval.
