## AN ACT

To appropriate the sum of \$3,133,000 from the United States Grant Special Fund for the fiscal year ending September 30, 1983, for the purpose of funding technical assistance projects in the Federated States of Micronesia, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. The sum of \$3,133,000, or so much thereof as may be
2	necessary, is hereby appropriated from the United States Grant Special
3	Fund for the fiscal year ending September 30, 1983, for the purpose of
4	funding technical assistance projects in the Federated States of Micronesia

15	specified in this act, and that no obligations are incurred in excess
16	of the sum appropriated. The authority of the allottee to obligate
17	funds appropriated by this act shall lapse when the funds are expended
