## AN ACT

To further amend Public Law No. 2-35, as amended by Public Law No. 2-42, appropriating the sum of \$637,600 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1982, for the purpose of funding public projects in the State of Ponape, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
