CONGRESSIONAL BILL NO. 3-303, C.D.1,
C.D.2

AN ACT

To further amend Public Law No. 3-18, as amended, by amending section 1 to appropriate the sum of \$45,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1984, for the purpose of providing supplemental funding for the Office of the Attorney General, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 3-18, as amended by
2 Public Laws Nos. 3-39 and 3-44, is hereby further amended to read
3 as follows:

4 "Section 1. Operating expenses of the executive branch.
5 The sum of \$1,077,100, or so much thereof as may be
6 necessary, is hereby appropriated from the General Fund
7 of the Federated States of Micronesia, and the sum of
8 \$4,727,115, or so much thereof as may be necessary, is
9 hereby appropriated from the United States Grant Special
10 Fund for the fiscal year ending September 30, 1984, for
11 the operations of the executive branch of the National
12 Government of the Federated States of Micronesia during
13 fiscal year 1984. The sums appropriated by this section
14 shall be apportioned as follows:


