CONGRESSIONAL BILL NO. 3-296, C.D.1,
C.D.2

AN ACT

To appropriate the sum of \$789,700 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1985, for the purpose of funding public projects in the State of Truk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$789,700, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the Feder-
3 ated States of Micronesia for the fiscal year ending September 30, 1985,
4 for the purpose of funding public projects in the State of Truk. The
5 sum appropriated herein shall be apportioned as follows:

9 (b) Purchase of Truk dispensaries' medical
10 supplies and equipment 10,000

11 (c) Purchase of Mortlock Super Dispensary

24	Section 2. All funds appropriated by this act shall be allotted,	
25	managed, administered, and accounted for in accordance with applicable	

1 law, including, but not limited to, the Financial Management Act of
2 1979. The allottee shall be responsible for ensuring that these funds,
3 or so much thereof as may be necessary, are used solely for the purpose
4 specified in this act and that no obligations are incurred in excess
5 of the sum appropriated. The authority of the allottee to obligate
6 funds appropriated by this act shall remain available until expended.
7 The allottee shall make a report on the status of the funds appro-
8 priated hereunder to the Congress during the May regular session, 1985.

9 Section 3. This act shall become law upon approval by the
10 President of the Federated States of Micronesia or upon its becoming
11 law without such approval.
