

THIRD CONGRESS OF THE FEDERATED STATES OF MICRONESIA

THIRD SPECIAL SESSION, 1984 CONGRESSIONAL BILL NO. 3-295, C.D.1, C.D.2

AN ACT

To appropriate the sum of \$320,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1985, for the purpose of funding public projects in the State of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$320,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the Feder-
3 ated States of Micronesia for the fiscal year ending September 30,
4 1985, for the purpose of funding public projects in the State of
5 Kosrae. The sum appropriated herein shall be apportioned in the
6 following manner:

- 7 (1) Commercial center and inventory for
- 8 Kosrae Island Cooperative Association \$40,000
- 9 (2) Kosrae hospital complex construction 38,000
- 10 (3) Leap, Kupya, Infat seawalls 10,000
- 11 (4) Finaunpea, Putuk Te and Lelu Island-proper
- 12 seawalls. 5,000
- 13 (5) Yewak and Malem seawalls 11,000
- 14 (6) Inpuspusa water system 3,000
- 15 (7) Farm roads 60,000
- 16 (8) Farm projects 35,000
- 17 (9) Koasr water system 2,000
- 18 (10) Utwa water system 3,000
- 19 (11) Extension of power and crop damage 20,000
- 20 (12) Utwa playground. 10,000
- 21 (13) Equipment for Public Safety Department 8,000
- 22 (14) Finkal, Taf, and Inpuspusa seawalls 8,000

2	(16)	Medical supplies and referral	15,000
3	(17)	Contribution to Ponape State Hospital	5,000

7 Section 2. All funds appropriated under subsections (1), (2), (13),
8 (16), and (17) shall be allotted to the Governor. Funds appropriated
9 under subsection (18) shall be allotted to the Chairman of the Kosrae
10 congressional delegation. All other funds appropriated under section 1
11 shall be allotted to the Kosrae State Commission on Improvement Projects.
12 All funds appropriated by this act shall be allotted, managed, adminis-
13 tered, and accounted for in accordance with applicable law, including,
14 but not limited to, the Financial Management Act of 1979. The allottees
15 shall be responsible for ensuring that these funds, or so much thereof
16 as may be necessary, are used solely for the purpose specified in this
17 act, and that no obligations are incurred in excess of the sum appro-
18 priated. The authority of the allottees to obligate funds appropriated
19 by this act shall lapse as of September 30, 1985, except that funds
20 appropriated under subsection (1) shall remain available for obligation
21 until such funds are expended. Funds appropriated under subsection (1)
22 shall be used exclusively for construction and purchase of inventory.
23 Allottees may reprogram up to 10 percent to and from funds appropriated
24 to each of the subsections in section 1.

3 such approval.
