## AN ACT

To appropriate the sum of \$1,199,959 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, for the purpose of providing post-secondary educational assistance funds to the States; limiting the purposes for which such funds can be used; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$1,199,959, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending September 30,
- 4 1987, for the purpose of providing post-secondary educational assistance
- 5 funds to the States. Such funds shall be deemed to have come from the
- 6 funds available under section 216(a)(3) of the Compact of Free Associa-
- 7 tion.
- 8 Section 2. The funds appropriated under section 1 of this act
- 9 shall be apportioned as follows:

- 16 Before any funds may be transferred from the General Fund to any State,
- 17 the Governor of that State must promulgate such regulations and
- 18 implement such accounting procedures as may be necessary to ensure that
- 19 all funds appropriated by this act are administered in a manner
- 20 consistent with section 216(a)(3) of the Compact of Free Association,

4	Section 4. All funds appropriated by this act shall be allotted,
5	managed, administered, and accounted for in accordance with applicable
6	law, including, but not limited to, the Financial Management Act of
7	1979. The allottee shall be responsible for ensuring that these funds,
8	or so much thereof as may be necessary, are used solely for the purpose
9	specified in this act, and that no obligations are incurred in excess
10	of the sum appropriated. The authority of the allottee to obligate
11	funds appropriated by this act shall lapse as of September 30, 1988.
12	Section 5. This act shall become law upon approval by the
13	President of the Federated States of Micronesia or upon its becoming
14	law without such approval.
