

AN ACT

To further amend Public Law No. 2-34, as amended, by further amending section 1, as amended by Public Laws Nos. 2-44, 3-12, 3-35, 3-50, and 4-79, to change the purpose of the funds appropriated thereby, to redesignate paragraphs, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 2-34, as amended by
2 Public Laws Nos. 2-44, 3-12, 3-35, 3-50, and 4-79, is hereby further
3 amended to read as follows:

4 "Section 1. The sum of \$846,200, or so much thereof as
5 may be necessary, is hereby appropriated from the General
6 Fund of the Federated States of Micronesia for the fiscal
7 year ending September 30, 1982, for the purpose of funding
8 certain public projects in the State of Truk. The sum
9 appropriated by this section shall be apportioned as
10 follows:
