THIRD SPECIAL SESSION, 1988 CONGRESSIONAL BILL No. 5-332, C.D.1, C.D.2

AN ACT

To appropriate the sum of \$180,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, for the purpose of funding certain public projects in the State of Truk, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. The sum of \$180,000, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the
3	Federated States of Micronesia for the fiscal year ending September
4	30, 1989, for the purpose of funding certain public projects in the
5	State of Truk. The funds appropriated by this act shall be deemed to
6	have come from the capital account of the Compact of Free Association.
7	Section 2. The sum appropriated under section 1 of this act
8	shall be apportioned as follows:
9	(1) Ta Airport project \$ 70,000
10	(2) Ulul Airport project 40,000
11	(3) Mortlock Junior High School improvement 10,000 Vetoed 9RH
12	(4) Southern Namoneas Junior High
13	School improvement 10,000 Vetred ANH

20	Section 3. All funds appropriated by this act shall be allotted,

managed, administered, and accounted for in accordance with applicable

22 law, including, but not limited to, the Financial Management Act of

Public Law No. 5 - 8 5 CONGRESSIONAL BILL No. 5-332, C.D.1, C.D.2

1	1979. The allottee for the funds appropriated under subsections (1)
2	and (2) of section 2 of this act shall be the President of the
3	Federated States of Micronesia, and the allottee for the
4	funds appropriated under subsections (3), (4), (5), (6), (7), (8),
5	and (9) of section 2 of this act shall be the Governor of the State
6	of Truk. Each allottee shall be responsible for ensuring that
7	these funds, or so much thereof as may be necessary, are used solely
8	for the purposes specified in this act, and that no obligations are
9	incurred in excess of the sum appropriated. The authority of the
10	allottees to obligate funds appropriated by this act shall lapse as o
11	September 30, 1989.
12	Section 4. This act shall become law upon approval by the
13	President of the Federated States of Micronesia or upon its becoming,
14	law without such approval.
