SECOND SPECIAL SESSION, 1990

CONGRESSIONAL BILL NO. 6-190, C.D.1, C.D.2

AN ACT

To appropriate the sum of \$60,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding tuition and fees to allow citizens of the Federated States of Micronesia to attend fisheries and maritime training programs, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$60,000, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending September
- 4 30, 1990, for the purpose of funding tuition and fees to allow
- 5 citizens of the Federated States of Micronesia to attend fisheries
- 6 and maritime training programs.
- 7 Section 2. The Secretary of the Department of Human Resources,
- 8 or his designee, shall promulgate regulations, pursuant to chapter
- 9 1 of title 17 of the Code of the Federated States of Micronesia,
- 10 governing the process for payment of tuition and fees for FSM
- 11 citizens attending the fisheries and maritime training programs.
- 12 No payment of tuition and fees shall occur until such regulations
- 13 are properly promulgated and in effect.
- 14 Section 3. All funds appropriated by this act shall be allotted,
- 15 managed, administered, and accounted for in accordance with applicable
- 16 law, including, but not limited to, the Financial Management Act of
- 17 1979. The allottee shall be responsible for ensuring that these
- 18 funds, or so much thereof as may be necessary, are used solely for
- 19 the purpose specified in this act, and that no obligations are
- 20 incurred in excess of the sum appropriated. The authority of the
- 21 allottee to obligate funds appropriated by this act shall not lapse.
