Commencement: 1st November 1946 (Cap. 16 of 1973)

1. This Ordinance may be cited as the Census Ordinance.

Short title

2. The Minister may, whenever he may deem it expedient, by Order directorder, direct that a census be taken of the inhabitants of the census and Gilbert Islands, and by such order appoint a census commissioner, and prescribe the time in relation to which the particulars missioner required by the census shall be stated, and the date upon which the census is to be taken.

3. (1) The census commissioner shall make arrangements and duties of cendo all such things as are necessary for the taking of a census in sus commisaccordance with the provisions of this Ordinance and for that sioner purpose shall arrange for the preparation and issue of the necessary forms and instructions and for the collection of the forms when completed.

(2) The census commissioner shall in the exercise of his powers and the performance of his duties under this Ordinance be Laws of the Gilbert Islands, Vol I, Sig 5

subject to the control of and comply with any directions given by the Minister.

Expenses

4. All expenses incurred in the taking of a census including such allowances, if any, as may be approved by the Minister for payment to any of the persons employed in the taking of the census shall be paid out of the Consolidated Fund.

Regulations for the taking of a census

- 5. For the purpose of enabling any order directing the taking of a census to be carried into effect the census commissioner may make regulations-
 - (a) providing for the division of the Gilbert Islands into areas or districts for the purpose of the census;
 - (b) providing for the appointment or engagement of persons to assist in the taking of the census, whether as superintendents, supervisors, enumerators, or otherwise and for the assignment to them of their duties;
 - prescribing the persons by whom and in respect of whom the returns for the purpose of this Ordinance are to be
 - (d) requiring the person in charge of any institution, whether public or private, to make returns in respect of the inmates
 - (e) requiring any persons employed for the purpose of the census to make a statutory declaration before a magistrate or before such officer appointed to supervise the taking of the census as the census commissioner may authorise to take such declaration;
 - prescribing the particulars to be stated on the census
 - (g) making provision in respect to any other matters with respect to which it is necessary to make provision for the purpose of carrying into effect the provisions of this Ordi-

Provided that no particulars shall be required to be stated on

any census return other than the particulars with respect to such matters as are specified in the Schedule: Provided further that no person shall be compelled to state

particulars relating to his religion if he objects thereto.

Obtaining of information

6. A person who is employed in the taking of the census or who is required in pursuance of the provisions of this Ordinance to fill in any return, may ask of any other person such questions as may be necessary for obtaining any of the particulars required in

7. Upon completion of the census the census commissioner Report shall make such reports of the census and abstracts of the returns as the Minister may direct.

8. (1) If any person—

Penalties

- (a) refuses or neglects to comply with or acts in contravention of any of the provisions of this Ordinance; or
- (b) being a person required under this Ordinance to make a statutory declaration with respect to the performance of his duties, makes a false declaration; or
- (c) being a person required by this Ordinance, to make, sign, or deliver any document, makes, signs, or delivers, or causes to be made, signed, or delivered, a false document; or
- (d) being a person required in pursuance of this Ordinance to answer any question, refuses to answer or gives a false answer to that question; or
- (e) being a person required in pursuance of the provisions of this Ordinance to perform any duties in connection with the taking of the census refuses, without reasonable cause, to carry out his duties;

he shall be liable to a fine of \$20.

- (2) If any person—
- (a) being a person employed in taking a census, without lawful authority publishes or communicates to any person otherwise than in the ordinary course of such employment any information acquired by him in the course of his employment; or
- (b) having possession of any information which to his knowledge has been disclosed in contravention of this Ordinance, publishes or communicates that information to any other person:

he shall be liable to imprisonment for 6 months or to a fine of \$100.

- 1. This Order may be cited as the Census Order 1990.
- 2. A Census shall be taken of the inhabitants of Kiribati between 6th and 21st of November 1990, and for the purpose of the said census IETE ROUATU is appointed Census Commissioner.
- 3. The time in relation to which the particulars required by the census directed by this Order shall be mid-night on the 6th day of November 1990.

CENSUS ORDINANCE (Cap 8)

CENSUS REGULATIONS 1990

In exercise of the powers conferred by section 5 of the Census Ordinace, the Census Commissioner hereby makes the following Regulations:-

1. These Regulations may be cited as the Census Regulations 1990 and shall apply to the conduct of the census directed to be taken by the Census Order 1990.

2. In these Regulations, unless the context otherwise requires - "dwelling" means any place whatsoever in which a person is living at the time prescribed and any place

Interpretation

Citation

Taking of census and appointment of Commissioner

Time in which census is taken which is wholly or partly used for human habitation at such time and includes -

- (a) any building, erection, tenement or part thereof used wholly or partly for human habitation;
- (b) any hotel, lodging-house, boardinghouse or club;
- (c) any prison, police station, barracks and public or private charitable, religious, educational or other institution;
- (d) any vessel within the territorial waters of Kiribati;

"occupier" means the person living in and in charge of a dwelling at the time prescribed, and includes every householder and the head of every family, living in the dwelling, and if there is no such person in charge of the dwelling any other person living in the dwelling at the time prescribed, and if the person in charge of any dwelling is a company, the manager, secretary or other officer in charge of the dwelling, and in the case of an institution the person in charge of the institution, and in the case of a vessel, the Master or other person in charge of the vessel;

"time prescribed" means midnight on the 6th of November 1990.

Appointment of Supervisors, etc.

3. The Census Commissioner may be writing under his hand specified in Schedule 1 to these Regulations appoint so many persons as he may deem necessary to be supervisors or enumerators within any island or part thereof for the purpose of carrying out the census therein.

Duties of Enumerator

4. Every enumerator shall comply with the instructions of the Census Commissioner and of the supervisor of his island or part thereof and shall carry out such duties as are assigned to him.

Manner of taking cen-

5. The Census shall be taken by means of the completion of a Census Return in the form specified in Schedule 2 to these Regulations.

Completion of Census Returns.

- (1) Subject to paragraph (2) every person in Kiribati shall -
 - (a) furnish to the best of his knowledge and belief the particulars required to enable the proper completion of a Census Return; or
 - (b) take all reasonable steps to ensure that such particulars are furnished on his behalf by some other person.
 - (2) The occupier of every dwelling shall furnish, to the best of his knowledge and belief, all the particulars required to enable the proper completion of a Census Return in respect of himself and of every person who -

- (a) is actually present in the dwelling at the time prescribed;
- (b) returns to or arrives in the dwelling within twelve hours after the time prescribed, such person not having been otherwise enumerated.
- 7. Any person acting as an enumerator under these Regulations shall carry with him his written appointment as such and shall, on being demanded so to do, produce and show it to the person making such demand.
