SCHEDULE

An Ordinance to make provision for public holidays

Commencement: 5th May 1937

- 1. This Ordinance may be cited as the Public Holidays Ordi- Short title nance.
- 2. (1) The several days mentioned in the Schedule, hereinaf- Certain days ter called "public holidays", shall be kept as holidays in all public to be holidays Offices in the Gilbert Islands:

Schedule

Provided that if any public holiday falls on a Saturday or a Sunday, the Monday next following shall be a public holiday unless otherwise ordered by the Minister by notice.

(2) Notwithstanding anything contained in subsection (1) when the anniversary of the birthday of the Heir to the Throne falls on any day of the week other than Monday such day shall not be a public holiday but either the preceding or the following

Monday, as the Minister shall appoint, shall be a public holiday in lieu thereof.

(3) When the 26th day of December falls on a Sunday the Monday and Tuesday next following shall be public holidays and when it falls on a Monday the Tuesday next following shall be a public holiday.

Bills due on a public holiday to be payable on day next following

- 3. (1) All bills of exchange and promissory notes which are due and payable on any such public holiday shall be payable and, in case of non-payment may be noted and protested, on the day next following such public holiday, and any such noting and protest shall be as valid as if made on the day on which the bill or note was made due and payable.
- (2) For all purposes of this Ordinance the day next following a public holiday shall mean the next following day on which a bill of exchange may lawfully be noted or protested.

Notice of dishonour, presentment or acceptance on day next following 4. When a day on which any notice of dishonour of an unpaid bill of exchange or promissory note shall be given, or a bill of exchange or promissory note should be presented or received for acceptance or accepted or forwarded to any referee or referees, is a public holiday, such notice of dishonour shall be given and such bill of exchange or promissory note shall be presented, received, accepted or forwarded on the day next following such public holiday.

Payments due on public holidays

5. No person shall be compellable to make any payment or do any act upon a public holiday which he would not be compellable to make or do on a Sunday; and the obligation to make such payment or do such act shall apply to the day next following such public holiday, and the making of such payment or doing of such act on such day next following shall be equivalent to payment of the money or performance of the act on the public holiday.

Alteration of days appointed to be public holidays 6. It shall be lawful for the Minister from time to time to declare by order either generally or specially in any year that any day appointed to be a public holiday shall not be a public holiday and that any day is appointed to be a public holiday whether by way of substitution for or in addition to the several days mentioned in the schedule or any of them.

Right to open public offices on holidays

7. Notwithstanding anything contained in this Ordinance the head of any Government department may open offices and works thereof and call upon all or any persons employed in such department to perform such of their duties on any public holiday as to such head of department may seem fit.

8. (1) No worker as defined in section 2 of the Employment Restriction of Ordinance, shall be compelled to perform any work on any public work on holiday save only such as shall be of immediate necessity for the public holicare and feeding of animals; cleanliness of yards, styes, stables, folds, manufactories and buildings; and other work indispensable Cap. 30 for the preservation of the property of his employer; which work shall not be for more than 2 hours duration either before the hour of 8 in the morning or after the hour of 4 in the afternoon.


(2) Every employer as defined in the said section who contravenes the provisions of this section shall be liable to a fine of


Section 2 (1977, S.2)

Omit from subsection (1) "Her Majesty's Government in the United Kingdom", substitute "the Republic".

AN ACT TO AMEND THE PUBLIC HOLIDAYS ORDINANCE (CAP. 81)

MADE by the Maneaba ni Maungatabu and assented to by the Beretitenti.

Short title and commencement

1. This Act may be cited as the Public Holidays (Amendment) Act 1992 and shall come into operation on 1 January 1993.

Amendment of section 2

2. Section 2 of the Public Holidays Ordinance is amended by repealing the several days mentioned in the Schedule and substituting the following -

"SCHEDULE (Section 2)

Ist day of January
Good Friday
The day after Good Friday
Easter Monday
9th day of May
12th day of July
The first Monday in August
10th day of December
Christmas Day
26th day of December



PUBLIC HOLIDAYS (AMENDMENT) ACT 1992

EXPLANATORY MEMORARDUM

- 1. The main purpose of this Act is to add to the Schedule to the Ordinance several other days which have been recognised and honoured as public holidays in Kiribati.
- 2. By doing so the current cumbersome practice of the responsible Ministry of advising the public in advance as what days in the next year are public holidays which are to be observed will no longer now be necessary.

AN ACT TO AMEND THE PUBLIC HOLIDAYS ORDINANCE (CAP. 81)

Commencement 2002

Short title

This Act may be cited as the Public Holidays (Amendment) Act 2002.

Amendment of Schedule

2. The Schedule to the Public Holidays Ordinance (Cap.81) is amended by repealing the whole of that Schedule and substituting a new Schedule as follows:-
