- 1. This Ordinance may be cited as the Religious Bodies Short title Registration Ordinance.
- 2. "Religious body" means any congregation, society or body Definition of in the Gilbert Islands consisting of or representing not less than 50 persons of the age of 21 years and upwards holding religious tenets in common and which has its own system of discipline and internal government.

3. (1) Any religious body as defined by this Ordinance may be Registration registered as a religious body under this Ordinance.

(2) A request for registration shall be submitted to the Minister by the duly recognised head of such religious body and shall be signed by such person and by 5 other members of the body in the presence of an administrative officer; and such request shall state the number of adherents to such body in the Gilbert Islands, the religious denomination of the body and the name in which it is desired to register such body:

Provided that if the religious body so requesting registration

does not include and represent the adherents for the whole of the Islands to the religious denomination to which it belongs then such request shall include a consent to such application for registration by the duly recognised head in the Islands of the religious denomination to which such body belongs.

(3) The Minister after making such inquiries as he shall deem necessary for the purpose of confirming any of the matters included in such request may at his discretion register the name and particulars of such religious body in a register book kept for that purpose and shall thereupon furnish to such religious body a certificate of registration in the Form 1 set out in the Schedule.

Schedule

Registration of trustees

- 4. (1) A memorial of the names of the trustees for any religious body so registered shall be submitted to the Minister for registration, provided that the trustees for any such religious body shall not exceed 5 in number.
- (2) Such memorial shall be in the Form 2 in the Schedule and shall be signed by the head of such religious body and two of the ministers, priests, deacons or elders thereof, and shall state that such trustees have been properly appointed in accordance with the constitution of such religious body:

Provided that the memorial of the names of trustees in respect of a religious body which does not include and represent the adherents for the whole of the Gilbert Islands to the religious denomination to which it belongs shall include a consent thereto by the duly recognised head in the Islands of the religious denomination to which such body belongs.

(3) On receipt of such memorial the Minister shall enter the particulars thereof in a register book kept for that purpose and upon such registration the names of the persons for the time being so registered shall be taken for all purposes as the names of the trustees of such religious body.

Change of trustees

5. In the event of the death, resignation, or removal from his trust of any trustee of a religious body, the requisite alteration in the names of the trustees of such body shall be effected by a memorial in the Form 3 in the Schedule to be signed and registered in the same manner as is prescribed by section 4 for the registration of a memorial of trustees and until such memorial is so registered such appointment of a new trustee shall have no operative effect.

Actions to be brought by or against trustees

6. (1) All actions and proceedings at law instituted or brought in relation to the property in the Gilbert Islands of any religious body shall be instituted or brought by or against the persons

registered as trustees for the time being of such religious body and any such action or proceeding shall be carried to its final termination notwithstanding any alteration in the registered trustees of such religious body after such action or proceeding has been commenced.

- (2) All actions and proceedings instituted or brought on behalf of a religious body shall be instituted or brought by the trustees of such religious body at their discretion and any sum ordered by any court to be paid by any such trustees, either as damages, costs or otherwise, shall, unless the court shall order to the contrary, be payable out of the property of the religious body vested in such trustees.
- 7. (1) The trustees registered under this Ordinance shall for all purposes of dealing with any interest in land or other property owners of be treated as the beneficial owners thereof:

Trustees to be property

Provided that in no case shall any such interest in land or other property devolve on the heirs or personal representatives of any trustee.

- (2) Where any interest in land or other property has been or is hereafter acquired by or on behalf of any religious body the assurance vesting such property in such trustees shall not only vest the property assured in the parties named therein but shall also effectually vest the same in the survivor or survivors of such trustees and, on the appointment of new trustees, in the new trustees for the time being together with the continuing trustees, if any, jointly, or if there are no such continuing trustees then in such new trustees and in each such case such new trustees shall be registered in accordance with sections 5 and without any further transfer or assurance whatsoever.
- (3) The trustees for the time being registered under this Ordinance may give, sell, exchange, lease or otherwise deal with any of the property vested in such trustees and may give a valid receipt for any moneys paid to them in respect of the sale, exchange, lease or dealing with any such property.

AN ACT TO AMEND THE RELIGIOUS BODIES REGISTRATION ORDINANCE (CAP 89)

Commencement:

MADE by the Mancaba ni Maungatabu and assented to by the Beretitenti.

Short title.

1. This Act may be cited as the Religious Bodies Registration (Amendment) Act 1985.

mendment of section 2 of Cap 89.

- 2. Section 2 of the Religious Bodies Registration Ordinance (Cap 89) is smended in the definition of "Religious Body" by:
 - (i) repealing the words "50 persons of the age of 21" and substituting the following:

"2 per cent of persons of the age of 18 years"; and

- (ii) inserting after "upwards" the following:

 "as indicated in the latest report of
 the Census Commissioner on the census
 of the inhabitants of Kiribati taken
 pursuant to the Census Ordinance (Cap 8)".
- 3. Nothing in this Act shall in any way affect or invalidate the registration of any religious body duly registered and made under the Religious Bodies Registration Ordinance (Cap 84) before the commencement of this Act.

RELIGIOUS BODIES REGISTRATION (AMENDMENT) ACT 1985

EXPLANATORY MEMORANDUM

- 1. This Act emends section 2 of the Religious Bodies
 Registration Ordinance which defines a religious body as
 "any congregation society or body in Kiribati consisting
 of or representing not less than 50 persons of the age of
 21 years and upwards holding religious tenets in common
 and which has its own system of discipline and internal
 government".
- 2. The proposed amendment is contained in Clause 2 of the Act. It seeks to increase the number of the members of a religious body, before it can qualify to register as a religious body from the current number of 50 persons of the age of 21 years to 2 per cent of persons of the age of 18 years of the whole population of Kiribati as contained in the latest Kiribati Census Report of the Census Commissioner taken under the Census Ordinance.
- 3. All religious bodies which had been registered under the Religious Bodies Ordinance before the Commencement of the Act will not in any way be affected by this Act if it becomes law. This is contained in clause 3 of the Act.
