1. This Act may be cited as the Supplementary Appropriation Act, 1979.

2. The issue from the Consolidated Fund is hereby authorised of a sum of twenty eight thousand one hundred and fifty eight dollars to be applied for recurrent expenditure to the service of the year ending on 31st December 1979.
