A BILL

FOR AN ACT

To provide for the withdrawal and expenditure of monies from the Treasury Fund and the Nauruan Housing Fund to meet the expenditure of the Republic for the Financial Year ending on the thirtieth day of June, Two thousand and Five.

BE IT ENACTED by the Parliament of Nauru as follows:

SHORT TITLE

1. This Act may be cited as the Appropriation Act 2004 - 2005.

INTERPRETATION

In this Act:

"estimates" means the estimates of revenue and expenditure of the Republic for the Financial Year as contained in the "2004-05 Budget" prepared and laid before the Parliament in pursuance of Article 59 (4) of the Constitution of Nauru.

"the Schedule" means the Schedule of Expenditure authorised for the financial Year ending thirtieth June 2005.

"the Treasury Fund" means the fund established under Article 58 of The Constitution of Nauru.

"the Financial Year" means the year commencing on the first day of July Two Thousand and Four and ending on the thirtieth day of June, Two Thousand and Five, inclusive of both dates.

"head" means a department or division of the expenditure of the Republic listed in the schedule to this Act.

"subhead" means a subdivision of a head appearing in the estimates.

COMMENCEMENT AND EXPIRY

3: This Act shall come into force on the twenty-sixth day of October, Two Thousand and Four and shall cease to have effect on the thirtieth day of June, Two Thousand and Five.

WITHDRAWAL OF MONEYS FROM THE TREASURY FUND

- 4: (1) Total sum not exceeding \$13,276,600 as authorised in the Schedule may be withdrawn from the Treasury Fund and expended in accordance with the estimates, to meet the expenditure of the Republic until this Act shall cease to have effect in accordance with Section 3.
 - (2) Where the Cabinet considers it necessary to increase the amount assigned in the estimates to a particular subhead within a Head, the Cabinet may direct that there shall be applied to the aid of that subhead a further sum out of any surplus arising on any other subhead within the same Head, but so that the total amount withdrawn and expended does not exceed the amount authorised for that Head in the Schedule to this Act.
 - (3) Where the Cabinet authorises a transfer of funds between subheads within a Head in accordance with sub-section (2), it shall cause to be laid before the Parliament at the first meeting of the Parliament after it has approved the transfer, a copy of the order of the Cabinet approving such transfer.

NAURUAN HOUSING FUND

5: Where monies are withdrawn from the Treasury Fund and expended as authorised in the estimates for the erection, maintenance and repair of Nauruan Housing, the Treasury Fund shall be reimbursed from the Nauruan Housing Fund to the extent of the expenditure and the Nauruan Housing Fund hereby charged accordingly.

INCOME FROM NAURUAN HOUSING

6: All deposits, purchase monies, rentals, interests and other monies paid in respect of the erection, maintenance or repair of Nauruan Housing provided in accordance with the expenditure authorised by Section 5 or the disposal of any assets acquired in connection therewith, shall be paid to the Nauruan Housing Fund.
