

AN ORDINANCE

To amend the Arms, Liquor and Opium Prohibition Ordinance 1936

(ASSENTED TO : 29/5/1967)

Be it ordained by the Legislative Council for the Territory of Nauru, in pursuance of the powers conferred by the Nauru Act 1965, as follows:-

Short title and citation.

1.-(1.) This Ordinance may be cited as the Arms and Opium Prohibition Ordinance 1967.

(2.) The Arms, Liquor and Opium Prohibition Ordinance 1936 is in this Ordinance referred to as the Principal Ordinance.

(3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the Arms and Opium Prohibition Ordinance 1936-1967.

Commencement.

2. This Ordinance shall come into operation on the date on which the Liquor Ordinance 1967 comes into operation.

Short title.

3. Section 2 of the Principal Ordinance is amended by omitting the words "and shall come into operation forthwith".

Definitions.

4. Section 4 of the Principal Ordinance is amended by omitting the definition of "Intoxicating liquor".

5. Section 5 of the Principal Ordinance is amended by omitting the words "intoxicating liquor".

6. Section 6 of the Principal Ordinance is amended by omitting the words -

"opium or intoxicating liquor, except in the case of intoxicating liquor where such supply is made under Licence from the Administrator to supply such ration as the Administrator may permit, or in

cases where intoxicating liquor is entrusted to a Chinaman in the performance of his duties in transporting goods including intoxicating liquors on behalf of persons who are not prohibited from intoxicating liquors under this Ordinance." and by inserting in their stead the words "or opium".

Possession of firearms etc. prohibited.

7. Section 7 of the Principal Ordinance is amended by omitting the words -

"intoxicating liquor or opium, except in the case of the ration of intoxicating liquor permitted to a Chinaman, which the said Chinaman may have in his possession only within the precincts of the Chinese Location, Denigomodu, the European Settlement of Yangor, and in the case of Government employees and other employees connected with the Government, within the Government Station,"

and by inserting in their stead the words "or opium".

Penalty for using firearms etc.

8. Section 8 of the Principal Ordinance is amended by omitting the words "shall drink or have in his possession any intoxicating liquor, or, unless expressly permitted as aforesaid,".

Repeal.

9. Section 10 of the Principal Ordinance is repealed.

Amendments in relation to decimal currency.

10. The Principal Ordinance is amended as set out in the Schedule to this Ordinance.
