TO AMEND THE LICENCES ORDINANCES 1922-1927.

I, the Administrator of the Island of Nauru, do hereby enact, order and proclaim as under :-

1. This Ordinance may be cited as the Licences Amendment Ordinance 1935 and shall be deemed to have come

into operation on the first day of January, 1935.

2. The Licences Ordinance 1922 as amended by the Licences Amendment Ordinance 1924 and as further amended by the Licences Amendment Ordinance 1925 and the Licences Amendment Ordinance 1927, is in this Ordinance referred to as the Principal Ordinance.

3. The Principal Ordinance as amended by this Ordinance may be cited as the Licences Amendment Ordinance

1922-1935.

4. By this Ordinance :-

(a) Section 15 which reads:-

"For every registration effected under this Ordinance a fee of ten shillings shall be paid at the time of registration by the person making such registration.'

is cancelled and the following substituted therefor:

"For every registration of a male dog effected under this Ordinance a fee of ten shillings shall be paid at the time of registration by the person making such registration. For every registration of a female dog effected under this Ordinance a fee of twenty shillings shall be paid at the time of registration by the person making such registration."

(b) In Item 1 of the schedule attached to the Principal Ordinance that portion reading:—

"Branch Store, that is a branch of a store for which a full licence fee has been paid-Yearly, £5.

Half-yearly, £2 10s."

is cancelled and the following substituted therefor :--

"Branch Store, that is a branch of a store for which a full licence fee has been paid-Yearly, £2 10s.

Half-yearly, £1 5s."

- (c) Item 4 of the schedule attached to the Principal Ordinance is cancelled and the following substituted therefor:
 - "4. Keeping and using or owning and permitting to be used—a Motor Car—Yearly, £3.

a Motor Cycle or Motor Cycle and Sidecar-Yearly, £1 10s.

Provided that a Motor Car, Motor Cycle or Motor Cycle and Sidecar kept by an officer of the Administration and used by him in connexion with his official duties, or kept by a Minister of Religion ordinarily officiating as such and used by him in connexion with his duties as such Minister of Religion, shall be exempt from payment of the licence fee hereby prescribed."

(d) Item 5 of the schedule attached to the Principal Ordinance is cancelled and the following substituted

therefor:

"Owning or being in possession of a dog-

For each male dog—Yearly, 10s. For each female dog-20s.
