The Cabinet makes the following Regulations under Section 38 of the *Agricultural Quarantine Act 1999*:

1 Citation

These Regulations may be cited as the *Plant and Animal Quarantine (Amendment) Regulations 2023*.

2 Commencement

These Regulations commence on the date they are notified in the Gazette.

3 Amendment of the *Plant and Animal Quarantine Regulations 2004*

These Regulations amend the *Plant and Animal Quarantine Regulations 2004*.


4 Amendment of Schedule 3

Schedule 3 is amended by:

- (a) deleting 'Form 4 Phytosanitary Certificate' and substituting 'Form 5 Phytosanitary Certificate';
- (b) deleting 'FORM 4 PHYTOSANITARY CERTIFICATE' and substituting 'FORM 5 PHYTOSANITARY CERTIFICATE'; and
- (c) inserting Form 4 before Form 5 as follows:
