Cabinet makes the following Regulations under section 102(2)(b) of the *Births Deaths and Marriages Registration Act 2017*:

#### 1 Citation

These Regulations may be cited as the *Births Deaths and Marriages Registration* (*Registration of Adoptions*) *Regulations* 2019.

#### 2 Commencement

These Regulations come into effect on the day they are notified in the Gazette.

#### 3 Notice of adoption order

For the purpose of section 27(1) of the Act, the prescribed form for a notice to the Registrar of Births Deaths and Marriages of an adoption Order by the Resident Magistrate is in Form 1 of Schedule 1.

#### 4 Register of Adoptions

For the purpose of Part 4 of the Act, the records to be kept and maintained by the Registrar shall be as set out in Form 2 of Schedule 1.

#### 5 Request for information

For the purpose of section 33 of the Act, the prescribed form for an application for a request for information or inspection of the Adoption Register is in Form 3 of Schedule 1.

#### 6 Fee

Schedule 2 prescribes the type of fee for the purpose of Section 33(b) of the Act.
