# REGULATIONS UNDER THE MOTOR VEHICLES (THIRD-

### PARTY INSURANCE) ORDINANCE 1967.

## MOTOR VEHICLES (THIRD-PARTY INSURANCE)

#### REGULATIONS

Citation.

These Regulations may be cited as the Motor Vehicles 1. (Third-Party Insurance) Regulations.

Definitions.

2.-(1.) In these Regulations, unless the contrary intention appears -

"certificate of insurance" means a certificate referred to in regulation 4 of these Regulations; "the Ordinance" means the Motor Vehicles (Third-Party Insurance) Ordinance 1967.

In these Regulations, a reference to a form by number shall be read as a reference to a form so numbered in the First Schedule to these Regulations.

Licence to Third Party Insurer.

3. The prescribed form for the purposes of sub-section (2.) of section 5 of the Ordinance is Form I.

Form of Certificate

- 4.-(1.) For the purposes of sub-section (1.) of section of Insurance, 11 of the Ordinance, the prescribed form is Form 2 or Form 4, as the case requires.
  - (2.) For the purposes of sub-section (2.) of section 11 of the Ordinance, the prescribed form is Form 3 or Form 5, as the case requires.

Forms of Third-Party Policy.

5.-(1.) A third-party policy shall be in accordance with Form 6 or Form 7, as the case requires.

(2.) A renewal of a third-party policy shall be in accordance with Form 8 or Form 9, as the case requires.

Change in 6. The notice under sub-section (3.) of section 19 of ownership of motor vehicle. the Ordinance may be in accordance with Form 10.
