ORDER UNDER ARTICLE 85 (6.) OF THE CONSTITUTION JUDICIARY ORDINANCE 1957-1968

WHEREAS Article 85 (6.) of the Constitution provides that within the period of two years after Independence the President may, by notice in the <u>Gazette</u>, make such adaptions to a law passed before Independence Day as he considers necessary for the purposes of bringing the provisions of that law into accord with the provisions of the Consititution

AND WHEREAS that Article further provides that the adaption shall be deemed to have effect from such date, not before a date before Independence Day, as is specified in that Order,

NOW THEREFORE I, HAMMER DEROBURT, the President of the Republic of Nauru, order the following adaptions of the <u>Judiciary Ordinance</u> 1957-1968.

1. All references to the Central Court, other than those appearing in sections 6 and 7 of the Ordinance are omitted and references to the Supreme Court are inserted in their place.

2. Division 4 of Part II of the Ordinance, which relates to the Court of Appeal, and Division 2 of Part III of the Ordinance, which relates to Appeals to the Court of Appeal, are omitted.

3. These adaptions shall be deemed to have effect from the Thirty-first day of January, One thousand nine hundred and sixty-eight.
