<u>Duties:</u>

The Senior Administrative Officer will be responsible to the Chief Secretary for carrying out investigations and making policy submissions in regard to public service administration, organisation and method work and special projects. He will be responsible for the supervision of the central registry

and typing services, broadcasting station, public library, and similar services, and for in-service training in these and other public service fields. Public relations matters, preparation of correspondence, official reports and new bulletins will be called for.

The officer will probably exercise financial authority and delegations in relation to public service administration in the context of generally assisting the Chief Secretary.

Duties: The Administrative Officer will be responsible to the Senior Administrative Officer as a major part of his duties for control of Public Service personnel functions and for the training of personnel in all aspects of this work. He will investigate and report on salary levels and conditions of service, establishment variation proposals, personnel management within the Public Service and related matters. The appointee will be expected to assist the Chief Secretary and the Senior Administrative Officer with special projects, reports and the day to day management of the Chief Secretary's Department.

Administrative Officer (Works): \$4400-5000 *

<u>Duties:</u> To assist the Director with the personnel, administrative and accounting functions of the Department which employs approximately 240 men.

He will be responsible to the Director for efficient personnel management, correspondence and the supervision and training of clerical staff. He will directly control stores and ordering of materials, the issue of furniture to government quarters and the maintenance of records. He will also be required to assist with the various financial operations of the Department, including recording expenditure, allocation of labour costs, budgeting and general accounting functions related to the expenditure of public monies.
