invite enquiries for the purchase by tender of a hotel under construction at Meneng, Republic of Nauru, Central Pacific, including certain construction and other materials, furnishings and other equipment, already purchased and on site or installed.

The structure, which is situated on land held on a twenty-five year lease from 31st October, 1968, is located at the south-eastern tip of Anibare Bay within two miles of the airfield, on a site commanding fine views of the foreshore, and is well placed to take advantage of any tourist potential of the Island.

Stage 1 of the project, already partly completed, provides for: Ground Floor -

Lounge and Dining Area of some 2,300 square feet, with adjoining Kitchen and Cool rooms; Entry Foyer and Main Stair, Public Toilets. Managers Office, Plant Room, and some 6,000 square feet planned for offices.

First Floor -

Thirty-four (34) twin bedrooms, small Guest lounge and Laundry facilities.

It should be noted that income taxation is not presently levied by the Republic of Nauru. All dealings in land must have the approval of the President of the Republic.
