Any person intending to commence civil, divorce or adoption proceedings in the Supreme Court and wishing to have them come on for hearing during the next Sessions should, therefore, take steps to commence them without delay and, in any event by not later than 27th April, 1970. The Registrar of the Supreme Court and the Clerk of the Courts will be pleased to advise what steps have to be taken to commence any proceedings.
