## PUBLIC SERVICE APPEALS BOARD

#### PROCEDURE

## GENERAL DIRECTIONS GIVEN BY THE BOARD

- 1. These directions apply fully to all appeals to the Board made otherwise than under the provisions of the Public Service Act, 1961-1968: where an appeal is brought under the provisions of that Act these directions apply except in so far as they may be inconsistent with those provisions.
- 2. Every appeal shall be made by notice in writing signed by the appellant personally and lodged with the Registrar, Supreme Court, as Secretary to the Board.
- 3. In the notice of appeal the appellant shall state clearly -
  - (a) whether he is appealing against the findings of the Chief Secretary or against the punishment as too severe or against both; and
  - (b) the grounds of his appeal, e.g. that notice of dismissal was irregular or that no disciplinary offence was admitted or established by the evidence.
- 4. Upon receipt of a notice of appeal, the Registrar will send copies of it forthwith to the Chief Secretary, the Chairman and the members of the Board.
- 5. The Chairman will fix a date and time for hearing the appeal and the Registrar will notify the Chief Secretary, the appellant and the members of the Board.
- 6. The Chief Secretary will, if possible at least seven days before the date of the hearing, supply the Registrar with copies of any notes of evidence taken during disciplinary proceedings, the notice of dismissal or other punishment, any previous warnings or punishments, and relevant letters, memoranda, etc., received from the appellant, sufficient for the Chairman, the members of the Board and the appellant each to receive a copy; and the Registrar will forthwith send a copy to each of them.
- 7. The Chief Secretary and the appellant may adduce evidence by affidavit; every such affidavit must be lodged with the Registrar not less than 3 days before the hearing together with sufficient copies for the Chairman, the members of the Board and the other party to the appeal; and the Registrar will forthwith send a copy to each of them.
- 8. At the hearing the Chief Secretary and the appellant may each appear in person or by representative or may be absent and unrepresented but present his case in the form of written argument, with or without evidence by affidavit; any party wishing to be absent and unrepresented but to present his case by written argument must lodge his written argument and any affidavits in support of it with, or send it by post to, the Registrar so that the Registrar receives it before the hearing date.
- 9. The appellant may not argue any ground not stated in his notice of appeal or adduce evidence in support of it, except by special leave of the Board; the Chief Secretary may not rely on any ground for the appellant's dismissal or other punishment other than grounds stated by him to the appellant at the time of the dismissal or punishment.

10. At the hearing the Board, having regard to the grounds of appeal, any admissions made and any other relevant matters, will direct which party is to commence, and will give such other directions as are necessary or convenient to enable it to hear and adjudicate upon the appeal in a fair and proper manner.
