AIR NAVIGATION ORDINANCES 1967

ESTABLISHMENT OF AERODROME

WHEREAS pursuant to the provisions of Section 6 of the Air Navigation Ordinance 1967 the Cabinet by notice in Gazette No. 47 of 1969 established an Aerodrome.

 $\,$ AND WHEREAS by reason of certain inconsistencies in the description of the Aerodrome set out in that Gazette notice it is desirable to restate the description of the Aerodrome.

NOW THEREFORE the Cabinet revokes the description therein contained and substitutes therefore the following description of the Aerodrome:-

The Aerodrome shall be within the area described in the Second Schedule to the Aerodrome (Acquisition of Land) Act 1952-1968 and shall comprise all that land contained between the southern boundary of the bitumen road on the northern side of the runway, and the northern boundary of the bitumen road on the southern side of the runway.
