# Funds for the Purchase of the Phosphate Industry

There was a loss of \$245,682 upon realisation of assets to enable the Government to purchase the Phosphate Industry. This was less than half the allowable limits set by Cabinet. To arrange for the purchase it was necessary to keep large sums in highly liquid securities which tend to have low yields. The losses upon realisation may be said to be more than offset by the investment of the case realised in higher yielding and more valuable assets. The loan made to the Republic for the purchase bears interest at 7-1/2% and is repayable over 10 years.
